- The lack of regional employment opportunities, reduced mobility and access to transportation for older people by comparison to younger people.
- The loss of esteem experienced by this target group through redundancy of skills acquired over several decades.
- The applicant's service will:-
 - (a) Actively seek vacancy listings from employers and publicly promote the virtues of this age group as

potential employees in the marketplace.

- (b) Conduct interviews by skilled staff who have personally experienced the client's circumstances and can empathise more fully with the process and be more productive for the client.
- (c) Make personal representations on behalf of each of the clients to heighten their employment prospects.
- (d) Run training sessions for clients to enable them to hone job search techniques, telephone techniques, letter writing, interview and other appropriate presentation skills.







1. Objectives

The objectives of this Notice are to:-

3. Commencement

4. Hunting of duck prohibited

The taking, destroying or hunting of any taxa of duck listed in the Schedule to this Notice is prohibited in Victoria absolutely during the periods:

- (a) from the beginning of the first Saturday of the 1998 duck open season (21 March) until 7.10 a.m. east of the line of longitude at 146°30' east, 7.20 a.m. between the line of longitude at 146°30' east and the line of longitude at 142°30' east and 7.30 a.m. west of the line of longitude at 142°30' east, on that day; and
- (b) from sunset on Sunday 17 May 1998 until sunset on Monday 8 June 1998.

5. Bag limits for duck

- (1) Subject to sub-clause (2) the bag limit for any day during the 1998 open season for the taxa of duck listed in the Schedule to this notice is five (5) game duck. The daily bag may include one (1) Australasian (Blue Winged) Shoveler but no more than three (3) teal (being any combination of Chestnut Teal and Grey Teal).
- (2) An additional five (5) Maned Duck (Wood Duck) may be taken on the first Saturday of the open season.

6. Penalty

Any person who contravenes this Notice is guilty of an offence and liable to a penalty not exceeding 25 penalty units.




