- No. 102/2004 (1) This Act, other than sections 5, 15 to 18, 21, 23 to 31 and 45, comes into operation on the day on which it receives the Royal Assent.
(2) Sections 5, 15 to 18 and 23 are deemed to have come into operation on 18 November 2004.
(3) Sections 21, 24 to 31 and 45 come into operation on a day or days to be proclaimed.
(4) If a provision referred to in sub-section (3) does not come into operation before 1 July 2005, it comes into operation on that day.
- No. 103/2004 (1) This Act (except section 37) comes into operation on the day after the day on which it receives the Royal Assent.
(2) Section 37 comes into operation on 1 July 2005.
- No. 104/2004 (1) This Part and sections 4(1), 4(2), 5, 6, 7, 8, 13, 14, 15, 24, 26, 27, 28, 33, 34, 35, 36(2), 36(5), 36(8), 36(11), 37(5), 40, 42, 46 and 48 come into operation on the day after the day on which this Act receives the Royal Assent.
(2) Section 21 is deemed to have come into operation on 1 July 2004.
(3) Section 45 is deemed to have come into operation on 1 March 2001.
(4) Sections 9, 10, 11, 12, 39(6), 41 and 49 come into operation on a day or days to be proclaimed.
(5) Subject to sub-section (6), the remaining provisions of the Act come into operation on a day or days to be proclaimed.
(6) If a provision referred to in sub-section (5) does not come into operation before 1 July 2006, it comes into operation on that day.

| | (2) | If a provision of this Act does not come into operation before 1 January 2006, it comes into operation that day. |
| No. 109/2004 | | This Act comes into operation on the day after the day on which it receives the Royal Assent. |
| No. 110/2004 | (1) | This Act (other than sections 8 to 13, 15, 16, 24, 26, 27, 29, 32, 33, 36, 38, 39, 41, 44 and 53 and Part 12) comes into operation on the day after the day on which it receives the Royal Assent. |
| | (2) | Sections 8 to 11 and 15 come into operation on a day or days to be proclaimed. |
| | (3) | If a provision referred to in sub-section (2) does not come into operation before 1 July 2005, it comes into operation on that day. |
| | (4) | Sections 12, 13, 16, 24, 26, 27, 29, 32, 33, 36 and 38 come into operation on 1 February 2005. |
| | (5) | Sections 39 and 41 come into operation on a day to be proclaimed. |
| | (6) | If a provision referred to in sub-section (5) does not come into operation before 30 September 2005, it comes into operation on that day. |
| | (7) | Section 44(1) is deemed to have come into operation on 16 June 2004. |
| | (8) | Section 44(2) is deemed to have come into operation on 9 December 2003. |
| | (9) | Section 53 comes into operation on a day to be proclaimed. |
| | (10) | If section 53 does not come into operation before 1 January 2006, it comes into operation on that day. |
| | (11) | Part 12 comes into operation on a day to be proclaimed. |
| | (12) | If Part 12 does not come into operation before 1 December 2005, it comes into operation on that day. |
