NOTICE OF ORDER

Order Prohibiting the Entry or Importation into Victoria of Livestock,
Livestock Products, Fittings and Vehicles

I, Hugh Millar, as delegate of the Minister for Agriculture, give notice of the:

- (a) revocation of the Order made under section 32 of the **Livestock Disease Control Act 1994**, prohibiting the entry or importation into Victoria of livestock, livestock products, fittings and vehicles that was made on 30 August 2007, notice of which was published in the Government Gazette No. S 205 on Friday 31 August 2007, and in the Age newspaper on Saturday 1 September 2007; and
- (b) making of an Order under section 32 of the **Livestock Disease Control Act 1994**, prohibiting the entry or importation into Victoria of livestock, livestock products, fittings and vehicles from New South Wales or Queensland to prevent the entry into Victoria of the exotic disease Equine Influenza.

The Order remains in force for 30 days.

PURIFICATION STANDARDS FOR NIGHT-SOIL AND SEWAGE

I, Joe Helper, Minister of Agriculture, acting under section 42(2) of the **Livestock Disease Control Act 1994** (the Act), by this Order

- (a) revoke the Order approving purification standards for night-soil and sewage which was made on 3 January 2003, and published in the Victoria Government Gazette number G2 on 9 January 2003 at page 42; and
- (b) approve –
 - 1. a method of purification which maintains night-soil throughout its mass at a temperature of not less than 100 degrees Celsius for a period of not less than 10 minutes as the standard to which night-soil must be purified if Division 2 of Part 4 of the Act is not to apply to cattle;
 - 2. a method of purification that results in water which –
 - (a) has received effective primary and biological or chemical treatment and which is characterised by having –
 - (i) a Biological Oxygen Demand (5 days at 20 degrees Celsius) not exceeding a median value of 50 milligrams per litre; and
 - (ii) a suspended solids content not exceeding a median value of 50 milligrams per litre; and

SPECIAL

- (b) has undergone a retention period of 25 days, or has passed through a sand filter having a depth of sand not less than 600 mm – the sand of such filter having an effective size not greater than 0.5 mm and a uniformity co-efficient not greater than 4, or has passed through an equivalent system approved by the Chief Veterinary Officer of the Department of Primary Industries

as the standard to which sewage must be purified if Division 2 of Part 4 of the Act is not to apply to cattle.
