1. Title

This Order is called the Administrative Arrangements Order (No. 199) 2008.

2. Authorising provisions

This Order is made under sections 3 and 5 of the **Administrative Arrangements Act 1983**.

3. Operation and effect of Order

This Order takes effect on 30 April 2008.

4. Definitions

In this Order –

‘**Body**’ means Minister, Department or officer;

‘**instrument**’ includes contract and agreement;

‘**Old Body**’ means a Body specified in Column 1 of an item in the Schedule;

‘**New Body**’ means a Body specified in Column 3 of an item in the Schedule;

‘**Schedule**’ means Schedule to this Order;

‘**transaction**’ includes –

- (a) agreement, bond, contract, deed or other consensual arrangement; and
- (b) action, appeal, arbitration, prosecution or other legal proceeding; and
- (c) assignment, charge, lease, mortgage, transfer or other dealing with property; and

SPECIAL

- (d) loan, guarantee, indemnity or other dealing with money; and
- (e) approval, consent, delegation, direction, licence, order, permit, requirement or other authority; and
- (f) notice; and
- (g) any other act, entitlement or liability at law.

5. Construction of references

In respect of each item in the Schedule, a reference to an Old Body –

- (a) in a provision of an Act specified in Column 2 of the Schedule; or
- (b) in a statutory instrument or other instrument made under an Act specified in Column 2 of the Schedule; or
- (c) in respect of any other matter or thing done under a provision of an Act specified in Column 2 of the Schedule –

is deemed to be a reference to the New Body.

6. Saving of existing transactions

If a transaction happened in relation to an Old Body before the day on which this Order has effect in relation to an item –

- (a) this Order does not affect the validity or continuity of the transaction; and
- (b) the transaction shall continue in the same way it would have continued if this Order had not been made; and
- (c) the transaction may be given effect to, or enforced or completed, by the New Body in the same way as it would have been given effect to, or enforced or completed, by the Old Body as if this Order had not been made.

7. Keeping financial accounts and reports

The Secretary, Department of Transport must ensure that financial accounts are kept and reports are provided for the purposes of the **Financial Management Act 1994** until 30 June 2008 in respect of functions under the Acts specified in item 4 in the Schedule that are transferred to the Secretary, Department of Innovation, Industry and Regional Development as if the functions had not been transferred.

8. Providing financial accounts and reports

The Secretary, Department of Innovation, Industry and Regional Development must, if requested by the Secretary, Department of Transport, provide the Secretary, Department of Transport with any financial accounts and records or other information required to enable the Secretary, Department of Transport to comply with clause 7.
