



- (b) control noise, behaviour, liquor consumption, animals, spruiking, busking, advertising sign, works and obstructions on roads, street trading, the use of toy vehicles and other activities;
- (c) protect the use of public places and control activities in or near them;
- (d) provide for safety in public places;
- (e) regulate and manage the legitimate display of street art, in or within view from, a public place so as to facilitate a vibrant urban culture;
- (f) provide for, control and manage the use of premises and vehicles in particular circumstances;
- (g) control, prevent and abate nuisances; and
- (h) provide for the peace, order and good government of the municipality.

General Purport: The general purport of the Local Law is as follows:

- (a) Part 2 of the Local Law contains provisions which aim to protect the amenity of public places for all citizens by controlling behaviour in public places and by prohibiting persons from causing damage to public places or acting in a socially unacceptable manner.
- (b) Part 3 of the Local Law aims to provide for the responsible management of public places so as to enhance the enjoyment of them by the general public, especially during major events.
- (c) Part 4 of the Local Law contains provisions which aim to enhance the appearance of streets and public places by controlling the placement of advertising signs in public places and on and between buildings and street art in, or within view from, a public place within the municipality and the placement of goods and the like in public places.
- (d) Part 5 of the Local Law contains provisions which aim to manage and facilitate responsible trading and entertainment on streets and public places to increase the attractiveness and comfort of these places, by controlling the soliciting of gifts and money, busking, selling and other behaviour on public places.
- (e) Part 6 of the Local Law contains provisions which aim to minimise the impact of works on roads on the amenity of the municipality and its residents by ensuring that obstructions do not interfere with the public's reasonable use of roads.

- (f) Part 7 of the Local Law contains provisions imposing building standards in respect to the Docklands Area.
- (g) Part 8 of the Local Law contains provisions which aim to control behaviour on bodies of water including Victoria Harbour.
- (h) Part 9 of the Local Law contains provisions which aim to improve the amenity of the municipality, in particular residential areas, by preventing nuisances caused by building works.
- (i) Part 10 of the Local Law contains provisions which aim to ensure that the appearance of buildings in the municipality is consistent with an image of the municipality that is safe, attractive and well maintained by controlling premises that have been allowed to reach a dilapidated, unsightly or dangerous condition.
- (j) Part 11 of the Local Law contains provisions to provide for the making of clear signage of road names and street numbers to assist in the management of the municipality and assist emergency services.
- (k) Part 12 of the Local Law contains provisions that aim to regulate and prohibit activities in public places not elsewhere covered by the Local Law to improve the amenity of the municipality and to protect other assets of the Council (such as pedestrian service signs).
- (l) Part 13 of the Local Law contains provisions relating to the granting of permits under the Local Law.
- (m) Part 14 of the Local Law contains provisions relating to the enforcement of the Local Law and prescribes the penalties for offences and for infringement notices.

2. Preliminary

The Bulk Entitlement (River Murray – Snowy Environmental Reserve) Order 2004 (the Bulk Entitlement Order) was made by the Minister on 23 December 2004 and notified in the Victoria Government Gazette S 284 dated 30 December 2004 at page 16. This environmental entitlement held by the Minister for Environment is being used so that water can be retained in other parts of the River Murray system to provide increased environmental flows in the Snowy River.

The Bulk Entitlement Order was amended by the Bulk Entitlement (River Murray – Snowy Environmental Reserve) Amendment Order 2006 made by the Minister for Water and published in the Victoria Government Gazette G6 dated 8 February 2007 at page 205 to change the Loddon River streamflow threshold at Appin South specified in sub-clause 13.1(b) of the Bulk Entitlement Order to reflect the changed flow regime due to increased environmental flow requirements specified in the Bulk Entitlement (Loddon River – Environmental Reserve) Order 2005.

3. Purpose

The purpose of this Order is to further amend the Bulk Entitlement Order to increase by 706 ML the Snowy Environmental Reserve entitlements specified in Schedules 1 and 4 to the BE Order.

4. Authorising provisions

This Order is made in accordance with section 44 of the **Water Act 1989**.

5. Commencement

This Order comes into operation on the day it is published in the Victoria Government Gazette.

Amending Notice 2009

I, Tim Holding, Minister for Water, under section 45 of the **Water Act 1989** give the following Notice –

1. Citation

This Notice may be cited as the Bulk Entitlement (River Murray – Goulburn–Murray Water) Amending Notice 2009.

2. Preliminary

The Bulk Entitlement (River Murray – Goulburn–Murray Water) Conversion Order 1999 (the BE Order) was made by the Governor in Council on 17 June 1999 and notified in the Victoria Government Gazette G24 dated 17 June 1999 at page 1421.

The BE Order was amended by the Bulk Entitlement (River Murray – Goulburn–Murray Water) Conversion Amendment Order 2005 made by the Governor in Council and published in the Victoria Government Gazette G3 dated 20 January 2005 at page 140 to reflect the water savings which were realised from the commissioning of a pipeline to supply the Woorinen Irrigation District from the River Murray.

The BE Order was further amended by the Bulk Entitlement (River Murray – Goulburn–Murray Water) Conversion Further Amendment Order 2007 made by the Governor in Council and published in the Victoria Government Gazette G5 dated 1 February 2007 at page 166 to change the Loddon River streamflow threshold at Appin South specified in sub-clause 13.1(b) of the BE Order to reflect the changed flow regime due to increased environmental flow requirements specified in the Bulk Entitlement (Loddon River – Environmental Reserve) Order 2005.

The BE Order was further amended by a Conversion Amending Notice 2007 made by the delegate of the Minister to reflect the changes to the BE Order as a consequence of the River Murray becoming a declared system. Notice of the making of this notice was published in the Victoria Government Gazette S144 dated 29 June 2007 at page 1.

3. Purpose

The purpose of this Notice is to make amendments to the BE Order that are necessary as a consequence of North East Catchment Management Authority's surrender of its water shares in the Mitta Mitta basin, the consequence of which is a reduction in Goulburn–Murray Water's high reliability entitlement associated with Dartmouth–Nyah diverters by 706 ML and low reliability entitlement associated with Mitta diverters by 339 ML.

4. Authorising provisions

This Notice is given in accordance with section 45 of the **Water Act 1989**.

5. Commencement

This Notice comes into effect on the day that the Bulk Entitlement (River Murray – Snowy Environmental Reserve) Amendment Order 2009 is published in the Government Gazette.
