25/2009 **Justice Legislation Amendment Act 2009**  
26/2009 **Transport Legislation General Amendments Act 2009**  
27/2009 **Public Administration Amendment Act 2009**  
28/2009 **Road Legislation Amendment Act 2009**

- 22/2009 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.  
(2) If a provision of this Act does not come into operation before 1 October 2009, it comes into operation on that day.
- 23/2009 This Act comes into operation on a day or days to be proclaimed.
- 24/2009 (1) This Part and Part 2 come into operation on the day on which this Act receives the Royal Assent.  
(2) The remaining provisions of this Act come into operation on a day or days to be proclaimed.
- 25/2009 (1) This Act (except Part 2) comes into operation on the day after the day on which this Act receives the Royal Assent.  
(2) Subject to subsection (3), Part 2 comes into operation on a day or days to be proclaimed.  
(3) If a provision of Part 2 does not come into operation before 1 October 2009, it comes into operation on that day.
- 26/2009 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.  
(2) If a provision referred to in subsection (1) does not come into operation before 1 January 2010, it comes into operation on that day.
- 27/2009 (1) This Part, Part 3, sections 18(1), 19(1), 20, 23, 24(1) and 25 and Part 6 come into operation on the day after the day on which this Act receives the Royal Assent.  
(2) Subject to subsection (3), sections 18(2), 19(2), 19(3), 21, 22 and 24(2) come into operation on a day to be proclaimed.  
(3) If sections 18(2), 19(2), 19(3), 21, 22 and 24(2) do not come into operation before 30 June 2009, they come into operation on that day.

**SPECIAL**

- (4) Subject to subsection (5), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
  - (5) If a provision referred to in subsection (4) does not come into operation before 1 October 2009, it comes into operation on that day.
- 28/2009
- (1) Subject to subsections (2) and (3), this Act comes into operation on the day after the day on which it receives the Royal Assent.
  - (2) Sections 4(2), 10, 19, 24, 25, 26(2), 27, 28, 29, 30, 31, 34(1) and (2), 42 and 53 come into operation on a day or days to be proclaimed.
  - (3) If a provision referred to in subsection (2) does not come into operation before 1 October 2010, it comes into operation on that day.
