A REVIEW OF VICTORIA'S ROAD

SAFETY REGULATIONS FOR VEHICLES – CALL FOR PUBLIC COMMENT

VicRoads is reviewing the road safety regulations.

The current Road Safety (Vehicles) Regulations are due to expire in November 2009.

As a result VicRoads is required to review the regulations and update them to reflect the current road safety needs of Victorian road users.

VicRoads invites interested members of the public to comment on the proposed Road Safety (Vehicles) Regulations.

These regulations set out the procedures for the registration of vehicles including registration fees, vehicle testing and vehicle safety.

A Regulatory Impact Statement (RIS) has been prepared for the Vehicles Regulations. The RIS includes information about the financial, economic and social impacts the proposed regulations are likely to have.
