Marine Act 1988

SECTION 15 NOTICE

I, Diane Julie Bates, the Director of Marine Safety, on the recommendation of Inspector Stephen Guilmartin, OIC Water Police/Search and Rescue Squads of Victoria Water Police, hereby give notice under subsection 15(2) of the **Marine Act 1988** that:

- (a) vessels involved with the 2010 Rip Curl Pro, operating at Bells Beach (Torquay), Johanna Beach, ocean beaches from Portsea to Gunnamatta and Phillip Island surf breaks, between the hours of 7.00 am and 6.00 pm daily during period from 28 March 2010 to 10 April 2010 are excluded from Clauses 2(a), 2(c), 4(a), 18, 19(a) and 19(d) of Notice No. 1 made under section 15(2) of the **Marine Act 1988**; and
- (b) vessels involved with the 2010 Rip Curl Pro, operating at Bells Beach (Torquay), Johanna Beach, ocean beaches from Portsea to Gunnamatta and Phillip Island surf breaks, between the hours of 7.00 am and 6.00 pm daily during period from 28 March 2010 to 10 April 2010 are excluded from specified equipment requirements prescribed in Regulation 228 of the Marine Regulations 2009.

The above provisions will apply to operators Glyndon Ringrose, Tony Ringrose, Tony Ray, Mark Skelton, Jeff Rowley and Byron Marsh and vessels with the registration LY 557, LY 559, LY 561 and LY 560.
