Notice of Ratification of Amendment

Amendment VC68

Amendment VC68 to the Victoria Planning Provisions and all planning schemes has been ratified by Parliament under sections 46AG and 46AH of the **Planning and Environment Act 1987**.

The Amendment will come into operation when notice of the approval of the Amendment under section 36 of the **Planning and Environment Act 1987** is published in the Government Gazette.

The Amendment changes the Victoria Planning Provisions and all planning schemes in Victoria by:

- changing Melbourne's Urban Growth Boundary and rezoning land in the Casey, Hume, Melton, Mitchell, Whittlesea and Wyndham Planning Schemes;
- changing the definition of Metropolitan Melbourne to include part of the Mitchell Planning Scheme;
- introducing a particular provision 'Statement of Underlying Provisions' and an associated incorporated document;
- applying the Public Acquisition Overlay to identify and reserve land for the Regional Rail Link, Outer Metropolitan Ring/E6 Transport Corridor and the Western Grassland Reserves;
- applying the Environmental Significance Overlay and introducing associated incorporated documents to protect environmentally significant areas;
- making the Minister for Planning the responsible authority for the Regional Rail Link; and
- removing the Restructure Overlay from land zoned Urban Growth Zone in the Mitchell Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment changes the Victoria Planning Provisions and all planning schemes in Victoria by:

- changing Melbourne's Urban Growth Boundary and rezoning land in the Casey, Hume, Melton, Mitchell, Whittlesea, and Wyndham Planning Schemes;
