



Restriction of Alcohol Consumption in Public Areas

Upon reading the material submitted in support of the application, including the affidavit of Giselle Bailey, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 13, 100 and 195 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption the Tribunal noted:

 The applicant operates its service as a program of the Good Shepherd Youth and Family Service. It operates a refuge and

- provides advice and assistance to women who are victims of violence by a male partner. It also provides services to the children of those women, some of whom have witnessed violence.
- The applicant currently employs persons in the following positions: intake worker, case worker, refuge worker, children/group worker and administration. In the event that the applicant seeks to recruit persons into those or other positions, it wishes to only advertise for and employ women so as to ensure that its clients, who have been the victims of male violence, feel secure at the applicant's premises and in obtaining its services. The refuge has a strict no male policy with regard to residents and visitors.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the Charter of Human Rights and Responsibilities Act 2006 (Charter). Arguably, this exemption limits the right to equal and effective protection against discrimination of men wishing to apply for employment with the applicant. I am satisfied that in the circumstances discussed above, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption to the applicant from the operation of sections 13, 100 and 195 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 26 January 2014.

(the applicant). The application for exemption is to enable the applicant to advertise for and employ only women in all positions at the applicant organisation (the exempt conduct).

Upon reading the material submitted in support of the application, including the affidavit of Janet Hall, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 13, 100 and 195 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption the Tribunal noted:

- The applicant was established in 1987 and is a community organisation funded by the Victorian Department of Human Services. It currently employs approximately 20 mainly part time workers. The applicant provides initial support, information and referral to individuals and professionals looking for information on family violence and family violence services. The applicant also provides a specialist library that is open to the general public, with resources relating to family violence, sexual assault and child sexual assault. Many of the female visitors to the library disclose experiences of abuse to the applicant's staff while looking for information on those subjects.
- The Victorian Government Women's Safety Strategy of 2002 notes that women are at greater risk of family violence than men, that women's experience of violence is often significantly different from men's experience and that violence against women is linked to inequality.
- About 90% of those who call the applicant's call centre are women. The majority of those with personal experience of abuse are women and, in the applicant's experience, they prefer to disclose family violence or sexual assault to female workers. All staff have contact with clients who may have suffered violence. As the majority of survivors of abuse are women and the majority of perpetrators are male, the applicant prefers to employ only females. This is likely to be of most assistance to the applicant's clients. In addition, providing female response workers is consistent with a model of female empowerment as a means of recovery from violence.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the Charter of Human Rights and Responsibilities Act 2006 (Charter).
 Arguably, this exemption limits the right

to equal and effective protection against discrimination of men wishing to apply for employment with the applicant. I am satisfied that in the circumstances discussed above, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption to the applicant from the operation of sections 13, 100 and 195 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 26 January 2014.

 - (b) identify any measures necessary to prevent recurrence of similar or related incidents; and
 - (c) specifically identify any measures necessary to ensure that the risk from loss of containment is as low as reasonably practicable and to ensure the continuing and sustainable safe operation of the facility; and
 - (d) identify what reduction in risk from loss of containment incidents might be achieved by the implementation of measures identified in (b) and (c) above and to which assets they might be attributed; and
 - (e) develop an implementation plan with respect to the measures identified in (b) and (c) above.
- 3. Esso must provide WorkSafe Victoria with a satisfactory written report by 1 July 2011 with respect to the matters identified in (a) (e) above.

The Licence Condition takes effect from 5.00 pm on 24 January 2011.

Safety on Public Land Act 2004

DECLARATION OF PUBLIC SAFETY ZONES

I, Lee Miezis, Executive Director Forests and Parks, as delegate of the Secretary of the Department of Sustainability and Environment, make the following declaration of public safety zones under section 4(1) of the **Safety on Public Land Act 2004**.

1. Definitions

In this declaration:

- (a) 'the Act' means the **Safety on Public Land Act 2004**;
- (b) 'the declared public safety zone' means the area declared under clause 2 of this declaration; and
- (c) 'the Schedule' means the Schedule to this declaration.

2. Declaration of Public Safety Zones

- (a) The areas of State forest contained within the location coordinates in the Schedule are declared to be public safety zones.
- (b) The extent of the public safety zones is described by the minimum planimetric extent using a North South orientated rectangle that encloses the area bound by:
 - (i) the south-west limit described by the first two metric coordinates (Easting and Northing); and
 - (ii) the north-east limit described by the next two metric coordinates (Easting and Northing).
- (c) The public safety zones are limited to all areas that contain State forest within an area identified by the coordinates in the Schedule.
- (d) The coordinates in Column 1 are provided in Map Grid of Australia (MGA) Universal Transverse Mercator (UTM) Zone number 55 or 54. These use the Geodetic Reference System 1980 (GRS80) spheroid.

3. Purpose for which the areas have been declared

Pursuant to section 5(1)(b) of the Act, the purpose for which the declared public safety zones have been declared to be public safety zones is specified as:

- (a) timber harvesting operations; and
- (b) the maintenance of public safety.

4. Period of the declaration

Pursuant to section 5(1)(c) of the Act, the period for which the declared public safety zones are declared to be a public safety zones is specified to be the period commencing from 27 January 2011 and ending on 30 June 2011 inclusive.

5. Activities prohibited

- (a) For the purposes of section 5(1)(e) of the Act, the activities that are prohibited in the declared public safety zones are specified to be all or any activity occurring or taking place in the declared public safety zones, other than an activity that does not interfere with any activity of an exempt person.
- (b) In clause 5(a) of this declaration
 - (i) 'activity' includes:
 - (a) entering the declared public safety zones;
 - (b) remaining in or being present in the declared public safety zones;
 - (c) walking in the declared public safety zones; and
 - (d) camping or setting up a camp in the declared public safety zones.

- (ii) 'exempt person' means any person or person within a class of person specified in:
 - (a) clause 8 of this declaration; and
 - (b) section 9 of the Act.
- (iii) 'interferes with' includes any circumstances in which the presence of the person in the declared public safety zones would prevent or hinder an exempt person from carrying out an activity.

6. Periods when access is prohibited

For the purposes of section 5(1)(d) of the Act, the times during which access to the declared public safety zones is prohibited is specified to be at all times.

7. Further restrictions or conditions (if any)

For the purposes of section 5(1)(f) of the Act, no further restrictions or conditions are specified to apply to the declared public safety zones.

8. Exempt persons or classes of person

Pursuant to section 5(2) of the Act, the following persons or classes of person are exempt from the operation of this declaration:

- (a) Persons undertaking timber harvesting operations which are authorised operations within the meaning of section 45 of the **Sustainable Forests (Timber) Act 2004** including:
 - (i) VicForests and its employees, agents and contractors;
 - (ii) persons who have an agreement with VicForests to harvest or sell timber resources and their employees, agents and contractors;
 - (iii) holders of licences or permits under section 52 of the **Forests Act 1958** and their employees, agents and contractors.
- (b) Persons undertaking timber harvesting operations in accordance with an approved Plan of Utilization as defined in the **Forests (Wood Pulp Agreement) Act 1996**.
- (c) Holders of licences or permits granted under section 52 of the **Forests Act 1958** to thin, cut and remove timber, to cut forest produce specified in the licence, to dig forest produce specified in the licence or to take away forest produce specified in the licence and their employees, agents and contractors.
- (d) Holders of Bee Farm licences, Bee Range area Licences, Apiary Occupation Rights granted under Subdivision 2 of Division 9, of Part 1 of the **Land Act 1958**, on Crown Land.
- (e) Employees, agents and contractors of the Department of Sustainability and Environment and the Department of Primary Industries engaged in carrying out their functions
- (f) Employees, agents and contractors of the Country Fire Authority, WorkSafe, Environment Protection Authority and the State Emergency Services engaged in carrying out their functions.
- (g) Members of the police force of Victoria engaged in carrying out their functions.
- (h) Persons appointed as environmental auditors under the **Environment Protection Act 1970** and their agents in carrying out their functions as forestry auditors engaged by the Department of Sustainability and Environment.
- (i) Persons who have been selected by the Department of Sustainability and Environment to act as audit observers and who are participating in this activity exclusively. Audit observers must be in the company of an environmental auditor appointed under the **Environment Protection Act 1970** and their agents in carrying out their functions as forestry auditors.

- (j) Holders of leases, licences, permits or other authorities (and associated employees, agents and contractors) under the Mineral Resources Development Act 1990, Extractive Industries Development Act 1995 and Petroleum Act 1998, other than holders of miners' rights and tourist fossicking authorities under the Mineral Resources Development Act 1990, whilst undertaking works associated with that lease, licence, permit or authority in the areas covered by the declaration provided that
 - (i) those works do not interfere with or hinder timber harvesting operations;
 - (ii) those classes of person have made prior arrangements with the forest manager to be in the area for the purpose of undertaking those works;
 - (iii) those classes of person abide by the Occupational, Health and Safety requirements established by the Department of Sustainability and Environment, VicForests or the contractor in charge of the site.

DECLARATION OF A CONTROL AREA IN VICTORIA FOR THE PURPOSE OF PREVENTING THE ENTRY OF THE PEST GRAPE PHYLLOXERA

Order in Council

The Governor in Council under section 9 of the Plant Health and Plant Products Act 1995 –

- (a) for the purpose of preventing the entry of the pest Grape Phylloxera (*Daktulosphaira vitifolii* Fitch) from other parts of Victoria, declares the area described in:

 - (ii) Schedule 2 to be a control area to be known as the Greater Geelong Phylloxera Control Area; and

- (b) specifies the prohibitions in Schedule 4 which are to operate in the control areas to prevent the entry of the pest Grape Phylloxera from other parts of Victoria; and
- (c) revokes the Order made under section 9 of the Act on 24 November 2009, and published in Government Gazette G48 on 26 November 2009.

and the Geographical Indication 'Heathcote' (Register of Protected Names, 21 August 2002), then an a westerly direction along the northern boundary of Geographical Indication 'Heathcote' to the intersection of the Geographical Indication 'Heathcote' and the Geographical Indication 'Bendigo' (Register of Protected Names, 27 June 2001), then in a westerly direction along the northern boundary of the Geographical Indication 'Bendigo' to the intersection of the Geographical Indication 'Bendigo' and the boundary of the Shire of Northern Grampians, then in a westerly, then southerly direction, along the northern and western boundary of the Shire of Northern Grampians to the intersection of the Shire of Northern Grampians and the Shire of Southern Grampians, then in a south-easterly, then south-westerly, direction along the eastern boundary of the Shire of Southern Grampians to the intersection of the Shire of Southern Grampians and Cassidy's Gap Road, then in a westerly direction along Cassidy's Gap Road to the intersection of Cassidy's Gap Road and Victoria Valley Road, then in a southerly direction along Victoria Valley Road to the intersection of Victoria Valley Road and Bundol Road, then in a south-westerly direction along Bundol Road to the intersection of Bundol Road, the Wannon River and the Geographical Indication 'Henty' (Register of Protected Names, 24 August 2000), then in a north-westerly direction along the boundary of the Geographical Indication 'Henty' to the intersection of the Geographical Indication 'Henty' and the Shire of West Wimmera, then in a northerly direction along the eastern boundary of the Shire of West Wimmera, to the intersection of Shire of West Wimmera and the Rural City of Mildura, then in an easterly direction along the southern boundary of the Rural City of Mildura to the intersection of the Rural City of Mildura and the Rural City of Swan Hill, then in an easterly direction along the southern boundary of the Rural City of Swan Hill to the intersection of the Rural City of Swan Hill and the Shire of Gannawarra, then in a southerly, then easterly direction, along the southern boundary of the Shire of Gannawarra to the intersection of the Shire of Gannawarra and the Murray River, then in a generally easterly direction along the Murray River to the point of commencement.

SCHEDULE 4

1. Definitions

In this Schedule -

'host material' means any plant, plant part or plant product of the genus *Vitis*, including potted vines, cuttings, rootlings, grapes, grape marc, grape must, juice, germplasm and plant and soil samples for diagnostic purposes;

'juice' means fresh, unclarified or unfiltered juice, but not juice filtered or otherwise processed so as to achieve a maximum particle size of 50 microns.

2. Prohibitions in the control areas

- (1) The entry into the control areas of
 - (a) any host material: or
 - (b) any agricultural equipment that has been used for the cultivation, harvesting, handling, transport or processing of plants, plant parts or plant products of the genus *Vitis*; or
 - (c) any package which has contained any plant, plant part or plant product of the genus *Vitis*; or
 - (d) soil originating from a property involved in the cultivation or handling of plants, plant parts or plant products of the genus *Vitis* –

is prohibited.

- (2) Subclause (1) does not apply in the case of any-
 - (a) host material, equipment, package or soil sourced from, or last used on, a property located in an area of Victoria declared as a control area for preventing the entry of phylloxera; or
 - (b) table grapes treated in a manner approved by the Manager Plant Standards.

Note: Section 9(3) of the **Plant Health and Plant Products Act 1995** provides that a person is guilty of an offence and liable for a penalty not exceeding 100 penalty units for entering a control area contrary to any prohibition or restriction, unless authorised to do so under a permit issued by the Secretary.
