





Control of Weapons Act 1990

DECLARATION OF DESIGNATED AREA UNDER SECTION 10D(1)

The Assistant Commissioner, Operations Support Department, acting as a delegate of the Chief Commissioner of Police, under section 10D(1) of the **Control of Weapons Act 1990** declares as a designated area the area in Werribee bounded by Manly Street, Coop Street and Cottrell Street East to the north, the east bank of the Werribee River to the west with the north point being defined as where the river meets Cottrell Street East and the southern point being defined as where the continuation of Barnes Place to the west would intersect the river, Comben Drive from Barnes Place to the intersection of Watton Street and continuing east to Cherry Street forming the south most border and Cherry Street to Market Road to the east, but not including those roads.



This declaration will operate on Wednesday 2 May 2012 from 1300 hours to 2100 hours during which time members of the police force are authorised to exercise the following powers:

- (a) In a public place in the designated area, without warrant, stop and search for weapons:
 - (i) any person;
 - (ii) any thing in the possession or control of the person;
 - (iii) any vehicle with a person in or on the vehicle; and
 - (iv) any thing in or on such vehicle;
- (b) detain a person or vehicle for so long as is reasonably necessary to conduct a search;
- (c) seize and detain any item the member reasonably suspects is a weapon; and
- (d) request a person who is the subject of a full search to disclose his or her identity.
