



- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the **Charter of Human Rights and Responsibilities Act 2006** (Charter). Arguably, this exemption limits the right to equality and in particular the right to equal and effective protection against discrimination of men who wish to make use of the women's room, be employed by the applicant in the above role or be a representative on the Women's Affairs Collective. I am satisfied that for the purposes of this interim exemption, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an interim exemption from the operation of sections 16, 18, 44, 64, 65, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

- Previous exemptions were granted to the applicant in similar terms in 2007 and 2010. The last exemption expires on 27 January 2013. I am not currently satisfied that an exception applies to the exempt conduct. Accordingly, in the absence of an exemption, after 27 January 2013, the exempt conduct would amount to prohibited discrimination.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the **Charter of Human Rights and Responsibilities Act 2006** (Charter). Arguably, this exemption limits the right to equality and in particular the right to equal and effective protection against discrimination of men or women who do not identify in one of the ways referred to above who wish to make use of the queer only space, be employed by the applicant in the above roles or be members of the Queer Committee or Queer Collective. I am satisfied that for the purposes of this interim exemption, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an interim exemption from the operation of sections 16, 18, 44, 64, 65, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force from 28 January 2013 until 30 April 2013.
