





Environment and Community Protection
Local Law (No. 1 of 2014)

Pursuant to section 119(2) of the **Local Government Act 1989**, notice is hereby given that the Wodonga City Council proposes to make Local Law No. 1 of 2014 – Environment and Community Protection Local Law for the purpose and general purport of:

- a. providing for the peace, order and good government of the municipal district;
- b. regulating or controlling activities related to the use or enjoyment of, or work on, council assets;
- c. protecting the health, safety and enjoyment of persons who:
 - reside in or visit the municipal district; or
 - use or work on council assets;
- d. protecting community property and council assets from damage and ensuring that such property or council asset is in a state fit for its intended or likely use;
- e. regulating or controlling conditions or activities that are detrimental, or that may cause detriment, to:
 - the amenity or environment of the municipal district; or
 - the health and safety of any person; or
 - the safety of any property;
- f. preventing annoying and unreasonable conditions or activities which interfere with, or may cause interference with, the reasonable use by, or enjoyment of, residents, or any other person, of roads or other facilities under the care and management of the council;
- g. ensuring that public health or nuisance problems do not occur due to unsatisfactory practices in caring and providing proper and clean facilities for animals or birds, which are kept at any property within the municipal district;
- h. regulating the collection and disposal of defined items of household refuse, recyclable goods and hard garbage;

- i. regulating the use of the council recycling and waste centre so that public health and safety and nuisance problems are avoided; and
- j. minimising potentially adverse environmental impacts of waste accumulation, collection or disposal.

If the proposed local law is adopted, the council's existing Environment and Community Protection Local Law (No. 3 of 2007) would be revoked.

Copies of the proposed local law, and the associated standards and guidelines, can be obtained from the Wodonga Council, 104 Hovell Street, Wodonga, during normal business hours, or can be viewed on the council's website at wodonga.vic.gov.au

A person may make a submission on the proposal. All submissions will be considered in accordance with section 223 of the **Local Government Act 1989**.

Only submissions received by council by 5 pm on Friday 23 May 2014 shall be considered.

Please note that copies of submissions (including submitters' names and addresses) may be made available at the council meeting at which the above proposal will be considered. The council is also required to make submissions available for public inspection for a period of 12 months.

Amendment C58

The Moyne Shire Council has prepared Amendment C58 to the Moyne Planning Scheme.

In accordance with section 8A(7) of the **Planning and Environment Act 1987**, Council may prepare an Amendment without authorisation from the Minister for Planning.

In this exemption, 'exempt conduct' means any of the following conduct, for the purposes only of enabling the Applicant to meet its obligations under contract and under the International Traffic In Arms Regulations (defined as 'ITAR' and as amended and in force at each time the conduct is engaged in) and only to the extent necessary to enable it to do any of the following –

 - (ii) any changes in the Personal Information that they have already provided or that may be required for ITAR compliance;
- (b) restrict ineligible employees and contract workers from accessing ITAR Controlled Material;
- (c) advertise positions with the Applicant as being subject to an ability of the prospective employee or contract worker to obtain approvals for access to ITAR Controlled Material;
- (d) reject applications by prospective employees and contract workers for positions which expose them to ITAR Controlled Material in circumstances where the individual concerned is ineligible;
- (e) remove existing employees and contract workers from positions and/or projects which expose them to ITAR Controlled Material in circumstances where they are ineligible; and
- (f) provide US Sponsor companies and the US Government with information relevant to the establishment of the eligibility of employees and contract workers of the Applicant who require, or are likely to require, access to ITAR Controlled Material.

'ITAR Controlled Material' means defence articles, technical data and defence services regulated by the ITAR.

'Personal Information' includes:

- (a) current and past citizenship;
- (b) country of birth;

- (d) current and past residential status held in any country other than the US or Australia.

'US Sponsor Company' means a US company which provides ITAR Controlled Material to the Applicant.

Upon reading the material submitted in support of the application and upon hearing submissions from the Applicant and for the Reasons for Decision given by the Tribunal on 16 April 2014, the Tribunal is satisfied that it is

appropriate to grant an exemption from sections 16, 18, 21, 44, 107 and 182 of the Act to enable the Applicant to engage in the exempt conduct.

The Tribunal hereby grants an exemption to the Applicant from the operation of sections 16, 18, 21, 44, 107 and 182 of the Act to enable the Applicant to engage in the exempt conduct.

This exemption is to remain in force from and including 1 May 2014 until 30 April 2019.

This exemption is subject to the condition that the Applicant must provide to the Tribunal and the Victorian Equal Opportunity and Human Rights Commission a written report for every 12-month period from the date of this exemption order. Each report must be provided within 21 days from the end of the relevant reporting period. Each report must detail:

- (a) the steps it has taken to comply with the terms of the exemption;
- (b) the number of persons affected by the exemption, the nature of the effects, and the steps taken to redress any adverse effects; and
- (c) the implementation of and compliance generally with the terms of the exemption.
