



EXEMPTION

Application No. H217/2014

The Victorian Civil and Administrative Tribunal has considered an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by Anglicare Victoria (the applicant). The application for exemption is to enable the applicant to advertise for and employ only women in all roles at its Women's House in Broadmeadows (the exempt conduct).

Upon reading the material filed in support of this application, including the affidavits of Maryanne Kara, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 16, 18, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption the Tribunal noted:

- The applicant provides welfare services at the Women's House in Broadmeadows (the House), which is a protected environment for women who have left abusive relationships and for recent women migrants seeking to integrate into Victorian society. The House is funded by the Department of Human Services.
- The House was established to address the special needs of women and operates from 9 am to 5 pm. It provides services such as

playgroups for new mothers, independent lifestyle skills courses, English as a second language classes, cultural awareness and integration in to the community. It also provides access to the wider community through the provision of an escorted, supervised bus service. In addition, childcare is provided for preschool children (including young boys) while their mothers attend courses at the House. Currently the staff at the House include administration assistants, team leaders, group facilitators, childcare workers and bus drivers. The exemption is sought in respect of all of these positions.

- The majority of women who use the House are from ethnic backgrounds where there are additional sensitivities to male presence. Some of the women who make use of the House's services have suffered trauma and torture. Many refugee women have spent time in internment camps where violence against women is said to be widespread. The applicant says that these women are more likely to relate to and trust with their experiences and stories to another woman.
- I am satisfied that, where staff are dealing with women clients who have experienced family or other violence or trauma at the hands of men, the evidence would support a finding that the exception contained in section 28 of the Act would apply. That is because those services are special services under section 88 of the Act and are likely to be most effectively provided by other women. To the extent that some women, for cultural or religious reasons, will only attend the House if only women staff it, may support a conclusion that the section 28 exception applies. However, in the case of the integration and cultural awareness programs and childcare services, I am not satisfied that the material before me sufficiently establishes that those services can be provided most effectively by women only, particularly given that women who attend the House are likely to interact with men on public transport and otherwise in the broader community. For these reasons I am not satisfied that, for each role within the applicant organisation, the section 28 exception applies. Where I am not satisfied that an exception applies to the services provided by the holder of each role within

the applicant organisation but accept that it is preferable that vulnerable women who have suffered family and similar violence receive services from women only and that some women may not attend the House and benefit from the services offered if men are present, it is appropriate that an exemption be granted.

- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the **Charter of Human Rights and Responsibilities Act 2006** (Charter). Arguably, this exemption limits the right to equality and in particular the right to equal and effective protection against discrimination of men who would wish to be employed by the applicant. I am satisfied that, in the circumstances discussed above, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption from the operation of sections 16, 18, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 5 November 2019.

EXEMPTION

Application No. H229/2014

The Victorian Civil and Administrative Tribunal has considered an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by Western Region Centre Against Sexual Assault (the applicant). The application for exemption is to enable the applicant to advertise for and employ only a woman in the role of Counsellor/Advocate (the exempt conduct).

Upon reading the material filed in support of this application, including the affidavit of Jane Vanderstoel, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 16, 18, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption the Tribunal noted:

- The applicant is located in Footscray and is one of 15 Victorian centres against sexual assault funded by the Victorian Government Department of Human Services. Its primary role is to provide counselling, advocacy and other support services to people who have experienced sexual assault and their non-offending family members and friends.
- The Counsellor/Advocate must be available to provide all aspects of the applicant's services, particularly in respect to the counselling team's work. That includes the provision of: crisis care to victims of recent sexual assault at the Sunshine Hospital Emergency Department; providing outreach services including at the Dame Phyllis Frost Centre; participating in a roster providing first response to people wishing to access the applicant's services; and managing a caseload of clients offering ongoing counselling responses to men, women and young people aged over 12 years who have experienced sexual assault.
- Over 90% of the applicant's clients are female and the applicant says that research shows that over 90% of perpetrators of sexual assault are male. The applicant has been informed by other sexual assault centres that, when clients are asked if they prefer to see a male or female counsellor, approximately 80% of male and female clients express a preference to see a female counsellor and, in some cases, clients refuse to see a male counsellor. If another counsellor is unavailable, the Counsellor/Advocate is required to step in to assist clients. When doing outreach work, only two counsellors are present. In these circumstances, the applicant considers it preferable for the holder of the role to be female to ensure that appropriate support can be given to all clients in these settings.
- I am satisfied that, where the Counsellor/Advocate works with and provides services to women seeking assistance and support in the context of sexual assault, the evidence would support a finding that the exception contained in section 28 of the Act would apply. That is because those services are special services under section 88 of the

Act and are likely to be most effectively provided by other women. However, given that the applicant provides some services to men and boys aged over 12 years, the exception contained in section 28 cannot apply to the employment of a woman only even where some men and boys express a preference to counselling from a woman. In addition, the material indicates that up to 20% of those clients may prefer to see a male counsellor. In these circumstances, I must consider whether an exemption ought to be granted. Although I am not satisfied that an exception applies to the Counsellor/Advocate, I am satisfied that an exemption ought to be granted to allow the applicant to employ only a woman in the role of Counsellor/Advocate role. That is because, given the proportion of women who access the applicant's services and have direct dealings with the Counsellor/Advocate and the fact that the majority of perpetrators of violence are male, I am satisfied that, for the majority of the applicant's vulnerable clients, it is preferable that they have access to counselling and advocacy services from women only.

- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the **Charter of Human Rights and Responsibilities Act 2006** (Charter). Arguably, this exemption limits the right to equality and in particular the right to equal and effective protection against discrimination of men who would wish to be employed in the Counsellor/Advocate role. I am satisfied that, in the circumstances discussed above, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption from the operation of sections 16, 18, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.
