Marine Safety Act 2010 Section 208(2)

NOTICE OF BOATING ACTIVITY EXCLUSION ZONE

In accordance with section 208(2) of the **Marine Safety Act 2010**, Parks Victoria (the waterway manager for the Yarra River upstream of port waters of the Port of Melbourne) gives notice that the waters of the Yarra River within the area detailed below in Table 1 are prohibited to all persons and vessels not registered and approved to take part in the Victorian Dragon Boats Association, Chinese New Year Regatta 2014.

Table 1: Yarra River Exclusion Zone

The waters of the Yarra River downstream of Spencer Street Bridge bounded by:

- (i) A line extending from a point 37°49'25.2048"S, 144°57'08.9856"E to a point 37°49'25.2120"S, 144°57'13.1004"E;
- (ii) A line extending from a point 37°49'25.2120"S, 144°57'13.1004"E to a point 37°49'24.08"S, 144°57'18.05"E;
- (iii) A line extending from a point 37°49'24.08"S, 144°57'18.05"E to a point 37°49'21.18147"S, 144°57'27.48344"E;
- (iv) The shore line extending from a point 37°49'21.18147"S, 144°57'27.48344"E; to a point 37°49'23.75505"S, 144°57'9.41691"E;
- (v) A line extending from a point 37°49'23.75505"S, 144°57'9.41691"E to a point 37°49'25.2048"S, 144°57'08.9856"E.

The exclusion zone takes effect between 8.30 am to 5.00 pm on Sunday 9 February 2014.
