Road Management Act 2004

DESIGNATION OF TOW AWAY AREA UNDER SCHEDULE 4 CLAUSE 5

Richmond Terminal Station Towing and Clearway Rights During Transformer Delivery

Clause 5 of Schedule 4 to the **Road Management Act 2004** provides that a State road authority may move, keep or impound any vehicle that is unlawfully parked or left standing in an area designated by the Minister (referred to in this instrument as a 'tow-away area'), and may charge the owner of the vehicle a reasonable fee.


For the purposes of that provision, I, George Mavroyeni, Acting Chief Operating Officer of the Roads Corporation and delegate of the Minister for Roads, designate the locations specified and shown on the attached plan, to be a tow-away area during transformer delivery to the Richmond Terminal Station.

This instrument takes effect at 12.00 am 16 March 2014 and expires at 12.00 pm 16 March 2014.
