Notice of Approval of Amendment

Amendment GC5

The Minister for Planning has approved Amendment GC5 to the Casey Planning Scheme, Greater Bendigo Planning Scheme and Monash Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment rezones nine sites being the former Brandon Park Secondary College, 6–30 Brandon Park Drive, Wheelers Hill, former Clayton Primary School, 29 Browns Road, Clayton, former Clayton West Primary School, 10 Alvina Street, Oakleigh South, former Oakleigh South Primary School, 1 Beryl Avenue, Oakleigh South, and former Monash Special Development School, 1 Renver Road, Clayton, in Monash City Council; former Dandenong Education Precinct (Doveton Secondary College), 64–70 Box Street, Doveton, former Doveton North Primary School, 25–35 Rowan Drive, Doveton, former Eumemmerring Primary School, 58 Doveton Avenue, Eumemmerring, in Casey City Council; and former Bendigo South East Secondary College, 41–73 Hattam Street, Golden Square, in Greater Bendigo City Council, from Public Use Zone 4 (Education) to a General Residential Zone or Residential Growth Zone and applies a Development Plan Overlay to each site.
