Order in Council

- ii. SCHEDULE TO THE ORDER IN COUNCIL

1. **Appointment Arrangements**
The appointment is part time.
2. **Period of Appointment**
In accordance with the terms of the Order.
3. **Duties and Responsibilities of the Position**
The duties and responsibilities of the position are set out in section 7 of the **Local Government (Brimbank City Council) Act 2009** (the Act).
4. **Termination Arrangements**
The termination arrangements are set out in section 7 of the Act.
5. **Payment Provisions**
An administrator is entitled to be paid remuneration and allowances which are fixed by the Minister under the Act.
6. **Superannuation Obligations**
Superannuation will be paid out in accordance with the **Commonwealth Superannuation Guarantee (Administration) Act 1992**.

7. Travel and Personal Expenses Arrangements

Travelling and other allowances for each member of the Panel are payable at a rate equal to the out of pocket expenses actually and necessarily incurred by that member in the exercise of the functions, powers, or duties of the Panel but not exceeding the reasonable allowance expense amounts determined by the Commissioner of Taxation for the income year in which the allowance is claimed.

8. Leave Arrangements

Leave arrangements for administrators will be a matter for negotiation with the Chairperson.
