APPOINTMENT OF A DELEGATE TO SEYMOUR HEALTH

Instrument of Revocation and Appointment

I, David Davis, Minister for Health, under section 40C(8) of the **Health Services Act 1988** (the Act):

- revoke the Instrument of Appointment of Michael Julian Wilson as a delegate to the board of Seymour Health as published in the Government Gazette on 21 December 2013; and
 - appoint Michael Julian Wilson as a delegate to the board of Seymour Health, on the following terms and conditions.
1. **Appointment arrangements**
The appointment is part time.
 2. **Period of Appointment**
Under section 40C(6)(a) of the Act, the appointment will commence on the date of publication of this instrument in the Government Gazette and will continue until 21 December 2014 unless ended earlier in accordance with paragraph 3 below.
 3. **Resignation/Revocation**
Under section 40C(7) of the Act, a delegate may resign by signed written notice delivered to the Minister for Health.
Under section 40C(8) of the Act, the Minister for Health may at any time revoke this appointment.
 4. **Payment Provisions**
Under section 40C(5)(c) of the Act, the delegate will be paid remuneration of \$26,901 per annum pro rata, to be paid by the Department of Health.
 5. **Superannuation**
Where the Department of Health incurs any obligation under the **Superannuation Guarantee (Administration) Act 1992** (Cth) with respect to the delegate, those obligations will be met in accordance with the Act.
 6. **Travel and personal expenses**
Under section 40C(6)(c) of the Act, the delegate is entitled to be reimbursed for reasonable travel and personal expenses. Claims for reimbursement are to be submitted to the Department of Health, which shall assess each claim and, for reasonable travel and personal expenses, issue a reimbursement payment.
 7. **Leave arrangements**
The delegate will not be entitled to paid leave of any kind.
