Murrungowar Road is an arterial road pursuant to Schedule 9 of the **Road Management Act 2004**.

This notice corrects an error in the road proclamation notice published in the Victoria Government Gazette (No. 815) dated 25 October 1950, page 5492, in which Murrungowar Road was incorrectly named as Murrungower Road.

All references to 'Murrungower' in that notice should be read as a reference to 'Murrungowar'.

Note: This notice only affects the VicRoads administrative road name and does not affect any other name for this road, including naming for property addressing purposes.

TABLE 1**EFFECTS ON ROAD NAMES**


1. Names in Column 2 are existing Vicmap Address names, which are unaffected by this notice.
