Road Safety Act 1986

DECLARATION UNDER SECTION 99B(4) IN RELATION TO NON-ROAD ACTIVITIES ON ROADS WITHIN CITY OF GREATER GEELONG FOR THE POLICE AND EMERGENCY SERVICES GAMES 2014 ON THURSDAY 24 APRIL 2014

1 Purpose

The purpose of this Declaration is to exempt participants in the Police and Emergency Services Games from specified provisions of the **Road Safety Act 1986** and regulations under that Act with respect to the Event, which is a non-road activity to be conducted on Eastern Beach Road, Bellerine Street and Ritchie Boulevard, Geelong.

2 Authorising provision

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister may, on the application of a person proposing to conduct a non-road activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

3 Commencement

This notice takes effect on Thursday 24 April 2014 at 8.30 am once the road is declared closed by Victoria Police.

4 Expiry

This notice expires on Thursday 24 April 2014 at 11.30 am.

5 Definitions

In this notice, unless the context or subject-matter otherwise requires –

- a) ‘Event’ means the Police and Emergency Services Games, to be held on Thursday 24 April 2014; and
- b) ‘Participants’ means participants in the Event, including officers, members and authorised agents of the Police and Emergency Services Games organising committee, whose presence is reasonably required to ensure the safe conduct of the Event.

6 Declaration

I, William Tieppo, as delegate of the Minister for Roads, under section 99B(4) of the **Road Safety Act 1986** declare that the provisions of the **Road Safety Act 1986** and regulations specified in Table 1 do not apply to Participants engaged in activities forming part of the Event on the highway specified in column 1 of Table 2 on the date and during the period specified in column 2 of Table 2.
