APPOINTMENT OF A DELEGATE TO THE BOARD OF GIPPSLAND SOUTHERN HEALTH SERVICE

Instrument Of Appointment

I, David Davis, Minister for Health, under section 40C(1) of the **Health Services Act 1988** (the Act), appoint Sherene Devanesen as a delegate to the board of Gippsland Southern Health Service.

The appointment is made on the following terms and conditions –

1. Appointment arrangements

The appointment is part time.

2. Period of Appointment

Under section 40C(6)(a), the appointment is for a period of 12 months from the date of publication of this instrument in the Government Gazette.

3. Resignation/Revocation

Under section 40C(7) of the Act, a delegate may resign by writing signed by that person and delivered to the Minister.

Under section 40C(8) of the Act, the Minister for Health may at any time revoke this appointment.

4. Payment Provisions

Under section 40C(5)(c) of the Act, the delegate will be paid remuneration at the rate of \$26,901.00 per annum pro rata.

5. Superannuation Obligations

Where the Department of Health incurs any obligation under the **Superannuation Guarantee (Administration) Act 1992** (Cth) with respect to the delegate, those obligations will be met in accordance with the Act.

6. Travel and personal expenses

Under section 40C(6)(c) of the Act, the delegate will be reimbursed for reasonable travel and personal expenses.

7. Leave arrangements

The delegate will not be entitled to paid leave of any kind.
