## **Water Act 1989**

### **CARRYOVER IN THE WERRIBEE, BROKEN, LODDON AND BULLAROOK WATER SYSTEMS**

The Minister for Water has made the following declarations and determinations under the **Water Act 1989**:

- Carryover for Water Shares in the Werribee Water System (Declaration and Determination) 2014
- Carryover for Bulk Entitlements and Environmental Entitlements in the Werribee Water System (Declaration and Determination) 2014
- Carryover for Water Shares in the Broken Water System (Declaration and Determination) 2014
- Carryover for Bulk Entitlements and Environmental Entitlements in the Broken Water System (Declaration and Determination) 2014
- Carryover for Water Shares in the Loddon and Bullarook Water Systems (Declaration and Determination) 2014
- Carryover for Bulk Entitlements and Environmental Entitlements in the Loddon and Bullarook Water Systems (Declaration and Determination) 2014

These declarations and determinations authorise the carryover of unused water allocations in the regulated Werribee water system of southern Victoria and give effect to changes in the Broken water system such that unused allocation can only be carried over against high-reliability water shares.

As the declarations and determinations for the Broken water system now differ from those for the Loddon and Bullarook water systems, and the separate instruments listed above have been created, the following instruments have been revoked:

- Carryover for Water Shares in the Broken, Loddon and Bullarook Water Systems (Declaration and Determination) 2010
- Carryover for Bulk Entitlements and Environmental Entitlements in the Broken, Loddon and Bullarook Water Systems (Declaration and Determination) 2010
