ORDER FOR AMENDMENT OF TRADING RULES FOR DECLARED WATER SYSTEMS (TRADE FROM KING TO OVENS)

1. I, Peter Walsh, Minister for Water, make the following Order to amend the Trading Rules for Declared Water Systems.

Title

2. This Order is called the Order for Amendment of Trading Rules for Declared Water Systems (Trade from King to Ovens).

Purpose

3. The purpose of this amendment is to allow trade of allocation and entitlement out of the King system to the Ovens system, subject to conditions.

Authorising Provision

4. This Order is made in accordance with sections 33AZ(2) and 64AZ(2) of the **Water Act 1989**.

Amendment

5. The amendment is as follows:

- a) In Rule 14, after '17D', **insert** 'and 17E,'
b) After Rule 17D, **insert** –

'Condition on trade from the King

17E. An application for a trade of entitlement from trading zone 9B to trading zone 9C must not be approved unless the works licence through which allocation under the entitlement can be taken includes a condition allowing Goulburn-Murray Rural Water Corporation to restrict take upon appropriate notice."

- c) In Table 1A of Schedule 1, after row 9B, **insert** –
(i)

9C	Lower Ovens Ovens River downstream of the confluence of the King River.

- d) In Table 2A of Schedule 2:
- (i) **insert** columns for trading zones 9A and 9B between columns for trading zones 7 and 10;
- (ii) **insert** rows for trading zones 9A, 9B and 9C between rows for trading zones 7 and 10;
- (iii) in the column for trading zone 9A –
A. **insert** 'b' in row 9B; and
B. **insert** 'a' in rows 9A and 9C; and
- (iv) in the column for trading zone 9B –
A. **insert** nothing in row 9A; and
B. **insert** 'a' in rows 9B; and
C. **insert** 'a' in row 9C; and
- (v) in Notes to Schedule 2, under note 5, **insert** –
'6. *Trading zone 9C is not a trading zone for any water share, but is a trading zone in which water may be used.*'

SPECIAL

Commencement

6. This Order comes into effect on 1 July 2014, or the date it is published in the Government Gazette, whichever is later.
