- 61/2014 (1) This Part, Part 9 and Division 4 of Part 10 and Part 11 come into operation on the day after the day on which this Act receives the Royal Assent.
- (2) Subject to subsection (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
- (3) If a provision referred to in subsection (2) does not come into operation before 1 March 2016, it comes into operation on that day.
- 62/2014 (1) This Act (except Part 2, Division 2 of Part 3 and Parts 4, 5 and 6) comes into operation on the day after the day on which it receives the Royal Assent.
- (2) Subject to subsection (3), Part 2, Division 2 of Part 3 and Parts 4, 5 and 6 come into operation on a day or days to be proclaimed.
- (3) If a provision of this Act does not come into operation before 1 September 2015, it comes into operation on that day.
- 63/2014 (1) This Part comes into operation on the day after the day on which this Act receives the Royal Assent.
- (2) Section 7(17) comes into operation on the later of –
- (a) the day on which section 6 comes into operation; or
- (b) the day on which section 5 of the **Sentencing Amendment (Baseline Sentences) Act 2014** comes into operation.
- (3) Subject to subsection (4), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
- (4) If a provision referred to in subsection (3) does not come into operation before 1 July 2015, it comes into operation on that day.

SPECIAL

- 64/2014 (1) This Part, sections 10 and 12 and Part 5 come into operation on the day after the day on which this Act receives the Royal Assent.
- (2) Subject to subsection (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
- (3) If a provision referred to in subsection (2) does not come into operation before 1 August 2015, it comes into operation on that day.
- 65/2014 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
- (2) If a provision of this Act does not come into operation before 30 June 2015, it comes into operation on that day.
- 66/2014 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
- (2) If a provision of this Act does not come into operation before 1 June 2015, it comes into operation on that day.
