ORDER AMENDING MINISTERIAL ORDER NO. 615 – AMENDMENT TO ORDER FIXING OF FEES ADMINISTERED BY THE

VICTORIAN REGISTRATION AND QUALIFICATIONS AUTHORITY

Ministerial Order 790

The Minister for Education and the Minister for Higher Education and Skills make the following Order.

TITLE

1. This Order may be cited as Ministerial Order No. 790.

PURPOSE

2. This Order amends Ministerial Order No. 615 which fixes fees in respect of applications that may be made to the Victorian Registration and Qualifications Authority and for certificates.

AUTHORISING PROVISIONS

3. This Order is made under the sections 4.3.16(3)(bc), 4.3.19(2)(a), 4.4.1(6), 4.4.2(1)(d), 5.2.12, 5.2.13, 5.10.4 of, and item 3 of Schedule 6 to, the Education and Training Reform Act 2006.

COMMENCEMENT

4. This Order takes effect from 10 October 2014.

- (b) after '(iii)' **insert** 'for the fees in Schedule 2 under the heading 'from 1/1/2015' the increase shall be the same rate of CPI that was applied under the heading 'from 1/1/2014'; and'; and
- (c) insert new subclause '(iv)' before 'subject to the other provisions of this Schedule'.
