DECLARATION OF INTERSTATE LAW

Order in Council

The Lieutenant-Governor, as the Governor's Deputy, with the advice of the Executive Council under section 81 of the **Corrections Act 1986** (the Act) revokes all previous orders made under Part 8A of the Act and makes a new Order declaring the following laws to be interstate laws –

- a) **Corrections Management Act 2007** (ACT);
- b) **Crimes (Administration of Sentences) Act 1999** (NSW);
- c) **Correctional Services Act 2014** (NT);
- d) **Corrective Services Act 2006** (Qld);
- e) **Correctional Services Act 1982** (SA);
- f) **Corrections Act 1997** (Tas); and
- g) **Prisons Act 1981** (WA).

This Order comes into effect on the date it is published in the Government Gazette.

Prisoners (Interstate Transfer) Act 1983

DECLARATION OF INTERSTATE LAW

Order in Council

The Lieutenant-Governor, as the Governor's Deputy, with the advice of the Executive Council under section 6 of the **Prisoners (Interstate Transfer) Act 1983** (the Act) revokes all previous orders under section 6 of the Act and makes a new Order declaring that –

1. For the purposes of section 6(1)(a) of the Act the following laws are interstate laws –
 - a) **Crimes (Sentence Administration) Act 2005** (ACT);
 - b) **Prisoners (Interstate Transfer) Act 1982** (NSW);
 - c) **Prisoners (Interstate Transfer) Act** (NT);
 - d) **Prisoners (Interstate Transfer) Act 1982** (Qld);
 - e) **Prisoners (Interstate Transfer) Act 1982** (SA);
 - f) **Prisoners (Interstate Transfer) Act 1982** (Tas); and
 - g) **Prisoners (Interstate Transfer) Act 1983** (WA).
2. For the purposes of section 6(1)(b) of the Act –
 - a) the Supreme Court of Victoria is a corresponding Court in relation to the Supreme Court of any State or Territory;
 - b) the County Court of Victoria is a corresponding Court in relation to any District Court, County Court or other Court being a Court of intermediate jurisdiction in relation to a Supreme Court and a court of summary jurisdiction of any State or Territory; and

SPECIAL

- c) the Magistrates' Court of Victoria is a corresponding court in relation to the Court of summary jurisdiction of any State or Territory.

Parole Orders (Transfer) Act 1983

DECLARATION OF CORRESPONDING LAWS

I, Edward O'Donohue, Minister for Corrections for the State of Victoria, pursuant to section 3 of the **Parole Orders (Transfer) Act 1983** (the Act), revoke all previous declarations made under section 3 of the Act and declare that the following laws are corresponding laws for the purposes of the Act –

- a) **Crimes (Sentence Administration) Act 2005** (ACT);
- b) **Parole Orders (Transfer) Act 1983** (NSW);
- c) **Parole Orders (Transfer) Act** (NT);
- d) **Parole Orders (Transfer) Act 1984** (Qld);
- e) **Parole Orders (Transfer) Act 1983** (SA);
- f) **Parole Orders (Transfer) Act 1983** (Tas); and
- g) **Parole Orders (Transfer) Act 1984** (WA).

This declaration comes into effect on the date it is published in the Government Gazette.
