Gambling Regulation Act 2003

MINISTERIAL ORDER

I, Edward O'Donohue MLC, Minister for Liquor and Gaming Regulation, by Order under section 3.4A.5(3) of the **Gambling Regulation Act 2003** specify the maximum number of gaming machine entitlements under which gaming may be conducted in the State to be 27,372.
