### NOTICE OF MAKING THE CODE OF PRACTICE FOR LOW RISK MINES

I, Kylie White, Executive Director Earth Resources Regulation of the Department of State Development, Business and Innovation, acting as delegate of the Minister for Energy and Resources under section 89E of the **Mineral Resources (Sustainable Development) Act 1990** (the Act), hereby give notice that the Code of Practice for Low Risk Mines (the Code) has been made.

The Code provides licensees under the Act with practical guidance on how low risk mines, as defined in the **Mineral Resources (Sustainable Development) Amendment Act 2014**, should operate to meet regulatory requirements and environmental standards in Victoria.

The varied Code has been amended to reflect recent changes to the definition of low impact exploration as defined by the **Mineral Resources (Sustainable Development) Amendment Act 2014**.
