ADVICE IN RELATION TO A NOTICE OF INTENTION TO REQUEST A WATERWAY RULE

I, Peter Corcoran, Director Maritime Safety (delegate of the Director, Transport Safety), hereby advise under section 193(3)(b)(ii) of the **Marine Safety Act 2010** that the proposed waterway rules for Dock Lake, Pine Lake, Lake Wartook and Moora Moora Reservoir, as submitted by Grampians Wimmera Mallee Water on 29 October 2014, are of a material nature and that Grampians Wimmera Mallee Water must comply with section 196 of the **Marine Safety Act 2010** before making a request for the making of the rules under section 194 of the **Marine Safety Act 2010**.

Section 196 of the **Marine Safety Act 2010** requires Grampians Wimmera Mallee Water to invite submissions and comments in relation to the proposed requests from the public.

I, Peter Corcoran, Director Maritime Safety (delegate of the Director, Transport Safety), hereby advise under section 193(3)(b)(ii) of the **Marine Safety Act 2010** that the proposed waterway rule for Rocklands Reservoir, as submitted by Grampians Wimmera Mallee Water on 29 October 2014, is of a non-material nature and that Grampians Wimmera Mallee Water is not required to comply with section 196 of the **Marine Safety Act 2010** before making a request for the making of the rules under section 194 of the **Marine Safety Act 2010**.

Section 196 of the **Marine Safety Act 2010** requiring a waterway manager to invite submissions and comments in relation to the proposed request from the public, does not apply.
