APPOINTMENT OF AN ADMINISTRATOR OF AMBULANCE VICTORIA

SCHEDULE TO ORDER IN COUNCIL

- 1. Appointment Arrangements**
The appointment is full-time.
- 2. Period of Appointment**
The appointment commences from the date of publication of this Order in Council in the Victorian Government Gazette.
- 3. Duties and responsibilities of the position**
Under section 35(3) of **Ambulance Services Act 1986** (the Act), an administrator appointed under this section is deemed to be the board of the ambulance service, and has all the functions, powers, immunities and duties of the board
Section 18 of the Act lists the functions of the board of an ambulance service including meeting the objectives of the service; developing operations, financial and business plans; establishing and maintaining effective systems and monitoring performance; and ensuring systems are in place to improve safety, quality and effectiveness.
- 4. Termination Arrangements**
Under section 35(4)(a) of the Act, the Governor in Council may, by Order published in the Government Gazette remove an administrator and appoint another administrator.
Under section 35(4)(c) of the Act, the Governor in Council may, by Order published in the Government Gazette declare that the administrator has ceased to be the administrator and that the board of directors has been re-established.
- 5. Payment Provisions**
There is no provision under the Act for the Governor in Council to approve remuneration.
- 6. Superannuation Obligations**
Not applicable.
- 7. Travel and Personal Expenses arrangements**
Not applicable.
- 8. Leave Arrangements**
Not applicable.
- 9. Prior Service**
Not applicable.
