



CORANGAMITE  
SHIRENOTICE OF INTENTION TO MAKE GENERAL LOCAL LAW NO. 1 2015  
AND LIVESTOCK LOCAL LAW NO. 2 2015

Notice is hereby given that Corangamite Shire Council intends to make the proposed General Local Law No. 1 2015 and proposed Livestock Local Law No. 2 2015 in accordance with sections 111(1) and 119 of the **Local Government Act 1989** (the Act).

The proposed Local Laws will supersede the current General Local Law No. 1 2009 and Livestock Local Law No. 2 2009 and are the result of a review of the current Local Laws against issues and concerns raised within the community since their adoption.

The proposed Local Laws are being made under section 111(1) of the Act and will operate throughout the municipal district of Corangamite Shire Council.

The purpose and general purport of the proposed General Local Law No. 1 2015 is to provide for:

- peace, order and good governance of the municipality;
- a safe and healthy environment so that the community within the municipality can enjoy a quality of life that meets its expectations;

- the control of activities, events, practices and behaviour on land which are dangerous or unsightly or could give rise to a nuisance or detriment to persons and the amenity of the neighbourhood;
- safe and fair use and enjoyment of public places;
- protection and enhancement of the amenity and environment of the municipality;
- fair and reasonable use and enjoyment of private land;
- protection of assets vested in the Council;
- regulation of behaviour in public places;
- controlling the consumption and possession of liquor in various circumstances and places and at various times;
- preventing obstructions to traffic and pedestrians from private land;
- facilitating the provision of equitable access to general public services which enhance the environment and quality of life in the municipal district;
- regulating the use of caravans and temporary dwellings;
- the making of decisions in the best interest of the whole community to maintain suitable infrastructure and to provide a sense of community;
- the control and regulation of the collection of wastes;
- uniform and fair administration of this Local Law; and
- best practice local law making principles of accessibility, accountability, compliance, consistency, currency, efficiency, enforceability, necessity and transparency.

The purpose and general purport of the proposed Livestock Local Law No. 2 2015 is to:

- regulate the movement and droving of livestock through and within the municipal district and the grazing of livestock within the municipal district;
- minimise damage to road pavements, formations, drainage, vegetation and surrounding areas arising from livestock;
- minimise the spread of livestock disease and noxious weeds in the municipal district;
- provide for the welfare of livestock when being driven, grazed or moved;
- provide for measures to alert other road users to the presence on roads of livestock in the municipal district in the interests of safe use of roads;
- regulate the adequacy of fencing of livestock and put in place mechanisms for rectifying inadequate fencing;
- make provision for fees or charges relating to the impounding of livestock and all other costs incidental thereto and for road use by livestock within the municipal district;
- prescribe penalties for contravention of any provisions of this Local Law; and
- provide generally for the peace, order and good government of the municipal district including in particular the administration of Council's powers and functions.

There are a range of proposed changes to the Local Law, some of which include new clauses. Many of the amendments ensure consistency with Acts of the Victorian Parliament, improve clarity, remove out-of-date elements and insert provisions that are relevant to current day activities.

Community Impact Statements have been prepared to inform the community about the proposed Local Laws and to assist any member of the public who may wish to make a submission to Council. A copy of the proposed Local Laws and Community Impact Statements can be obtained from the Corangamite Shire Council offices (181 Manifold Street, Camperdown, and on Council's website, [www.corangamite.vic.gov.au](http://www.corangamite.vic.gov.au)).

Copies of the proposed Local Laws and supporting documents may also be viewed at Camperdown Library, Cobden Library, Derrinallum Library, Terang Library, Timboon Library and Port Campbell Visitor Information Centre.

Any person affected by the proposed Local Law may make a written submission relating to the proposed Local Law under section 223 of the Act. Written submissions must be received by 5.00 pm on Friday 6 November 2015, addressed to Andrew Mason, CEO, Corangamite Shire Council, PO Box 84, Camperdown, Victoria 3260.

In their written submission, a person may also request to be heard by Council in support of their submission, prior to Council considering the proposed Local Law.
