Child Wellbeing and Safety Act 2005

CHILD SAFE STANDARDS

I, Jenny Mikakos, Minister for Families and Children, in accordance with section 17 of the **Child Wellbeing and Safety Act 2005**, make the following Child Safe Standards:

1. Child Safe Standards

In complying with the Child Safe Standards, an applicable entity or individual carrying on a business to which the Child Safe Standards apply must include the following principles as part of each standard:

- promoting the cultural safety of Aboriginal children
- promoting the cultural safety of children from culturally and/or linguistically diverse backgrounds
- promoting the safety of children with a disability.

To create and maintain a child safe organisation, an applicable entity or individual carrying on a business to which the Child Safe Standards apply must have:

- Standard 1: Strategies to embed an organisational culture of child safety, including through effective leadership arrangements
- Standard 2: A child safe policy or statement of commitment to child safety
- Standard 3: A code of conduct that establishes clear expectations for appropriate behaviour with children
- Standard 4: Screening, supervision, training and other human resources practices that reduce the risk of child abuse by new and existing personnel
- Standard 5: Processes for responding to and reporting suspected child abuse
- Standard 6: Strategies to identify and reduce or remove risks of child abuse
- Standard 7: Strategies to promote the participation and empowerment of children.

2. Commencement

This comes into effect on 1 January 2016.

MINISTERIAL ORDER NO. 873

Welton Primary School Council

Order Amending the Constituting Order

The Deputy Secretary, Regional Services Group, DET, on behalf of the Minister for Education, makes the following Order:

Objective

1. The objective of this Order is to amend the constituting Order by decreasing the total membership and the number of members from the Community member category and for that purpose to exclude the application of Clause 5B.4(b) of the School Council Composition and Elections Order (Ministerial Order No. 52).

Definition

2. In this Order ‘constituting Order’ means the Order in Council dated 3 August 1976 constituting Welton Primary School Council, as amended.

Authorising provision

3. This Order is made under section 2.3.2(6)(d) and all other enabling provisions of the **Education and Training Reform Act 2006**.

Commencement

4. This Order takes effect on the day it is made.

Exemption from Clause 5B.4 (b) of the constituting Order

5. For the purposes of this Order Clause 5B.4(b) of the School Council Composition and Elections Order (Ministerial Order No. 52) does not apply.
