Notice of Approval of Amendment

Amendment C100

The Minister for Planning has approved Amendment C100 to the Moonee Valley Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment introduces the Activity Centre Zone to the Moonee Valley Planning Scheme and inserts a schedule to the zone to apply to the Moonee Ponds Activity Centre. The Amendment also includes related changes to the Municipal Strategic Statement, the deletion of a schedule to the Special Use Zone, the application of an Environmental Audit Overlay to a number of properties and rezoning of land from a General Residential Zone to a Public Use Zone 4.

The Minister for Planning has approved Amendment C155 to the Moonee Valley Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment rezones land to the west of Moonee Valley Racecourse from Comprehensive Development Zone to Activity Centre Zone, including the land as Precinct 9 in Schedule 1 to the Activity Centre Zone – Moonee Ponds Activity Centre.
