### ORDER UNDER SECTION 56 SURRENDERING INTERESTS IN UNRESERVED CROWN LAND

### ORDER UNDER SECTION 62 FOR REVOCATION OF PART OF THE TEMPORARY RESERVATION OF CROWN LAND

#### Order in Council

The Governor in Council, under section 62(2) of the **EastLink Project Act 2004** (the Act) and on the recommendation of the Minister for Roads and Road Safety given in accordance with section 62(1) of the Act, revokes the Order in Council dated 4 December 2001 (the Order), which temporarily reserves certain land for conservation, recreation, leisure and tourism purposes, to the extent that the Order relates to the land shaded green and hatched on the plans numbered LEGL/14-569 signed by the Surveyor-General.


