10/2015	(1)	This Act comes into operation on the day after the day on which it receives the Royal Assent.				
11/2015	(1)	This Act comes into operation on 1 March 2016.				
12/2015	(1)	This Act (except Part 5, sections 12 and 13, Part 7 and Part 8) comes into operation on the day after the day on which it receives the Royal Assent.				
	(2)	Subject to subsection (3), Part 5, sections 12 and 13, and Part 7 and Part 8 come into operation on a day or days to be proclaimed.				
	(3)	If a provision referred to in subsection (2) does not come into operation before 1 December 2015, it comes into operation on that day.
