14/2015 **Jury Directions Act 2015**
15/2015 **Mental Health Amendment Act 2015**
16/2015 **National Parks Amendment (Prohibiting Cattle Grazing) Act 2015**

- 13/2015 (1) This Act comes into operation on the day after the day on which it receives the Royal Assent.
- 14/2015 (1) Section 1, Division 4 of Part 10 and this section come into operation on the day after the day on which this Act receives the Royal Assent.
- (2) Division 1 of Part 5 comes into operation on the same day as section 3 of the **Crimes Amendment (Sexual Offences and Other Matters) Act 2014** comes into operation.
- (3) Subject to subsection (4), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
- (4) If a provision referred to in subsection (3) does not come into operation before 29 June 2015, it comes into operation on that day.
- 15/2015 (1) Part 1 and sections 25(2), 28 and 29 come into operation on the day after the day on which this Act receives the Royal Assent.
- (2) Subject to subsection (3), the remaining provisions of this Act come into operation on a day to be proclaimed.
- (3) If a provision of this Act referred to in subsection (2) does not come into operation before 1 June 2016, it comes into operation on that day.
- 16/2015 (1) This Act comes into operation on the day after the day on which it receives the Royal Assent.
