### NOTICE OF DECISION

#### Gambling Regulations 2015

I, Jane Garrett MP, Minister for Consumer Affairs, Gaming and Liquor Regulation and Minister responsible for the **Gambling Regulation Act 2003**, give notice under section 12 of the **Subordinate Legislation Act 1994** of my decision to make the proposed Gambling Regulations 2015.

A Regulatory Impact Statement for the proposed Regulations was released for public comment on 27 April 2015. Five submissions were received in response to the Regulatory Impact Statement.

I have reviewed the submissions and intend to make the proposed Regulations with the following amendments:

- the provision that loyalty scheme providers must include specified information about the state-wide pre-commitment system in player activity statements has been amended to include reference to 'YourPlay', which will be the name of the system, and to remove reference to players seeking advice from gaming venue staff
- the provision that a person who conducts a trade promotion lottery must ensure a prize winner does not incur a cost to accept their prize has been amended to only apply to a non-trivial cost and where the prize winner is 'required' to incur the cost to accept their prize
- the provision that a person who conducts a trade promotion lottery may only substitute a prize with one of equal or greater value with the written agreement of the prize winner has been amended to allow a substitution without the prize winner's agreement where the person conducting the trade promotion lottery has made reasonable attempts to reach an agreement and the inability to provide the advertised prize is outside their control.

The commencement date for the proposed Regulations will be 20 June 2015.
