- 20/2015 (1) This Part, Part 4 and Part 14 come into operation on the day on which this Act receives the Royal Assent.
- (2) Part 13 is taken to have come into operation on 25 October 2014.
- (3) The remaining provisions of this Act (except Part 6, Part 7 and Part 16) come into operation on the day after the day on which this Act receives the Royal Assent.
- (4) Part 6 comes into operation on 1 July 2015.
- (5) Subject to subsections (6) and (7), Part 7 and Part 16 come into operation on a day or days to be proclaimed.
- (6) If a provision of Part 7 does not come into operation before 1 July 2017, it comes into operation on that day.
- (7) If a provision of Part 16 does not come into operation before 1 July 2016, it comes into operation on that day.
- 21/2015 (1) Subject to subsection (2), this Act comes into operation on 1 August 2015.
- (2) The following items in Schedule 1 are taken to have come into operation on the following dates –
- (a) item 9 on 1 July 2014;
- (b) item 16 on 1 July 2014;
- (c) item 19 on 29 June 2014;
- (d) item 23 on 30 November 2013;
- (e) item 62 on 30 June 2014;
- (f) item 66 on 1 July 2014.
- 22/2015 (1) This Act comes into operation on the day after the day on which it receives the Royal Assent.
