## Liquor Control Reform Act 1998

### MINISTERIAL ORDER UNDER SECTION 66AC(1) OF THE LIQUOR CONTROL REFORM ACT 1998

I, Jane Garrett MP, Minister for Consumer Affairs, Gaming and Liquor Regulation, under section 66AC(1) of the **Liquor Control Reform Act 1998**, and in consultation with the Minister administering the **Small Business Commissioner Act 2003** and the Minister administering Part V of the **Drugs, Poisons and Controlled Substances Act 1981**, specify a licence as a licence held by a small business if:

1. liquor was produced by the licensee, and the volume of liquor that was produced by the licensee in the prescribed period is:
  - (a) in the case of spirits, less than 8,750 litres;
  - (b) in the case of wine, less than 28,500 litres;
  - (c) in the case of cider, less than 100,000 litres;
  - (d) in the case of beer, less than 100,000 litres; and

Note: if the liquor produced by a licensee goes over the production threshold described in any one of (a), (b), (c) or (d), that licensee must report for all the categories that they produce liquor in.

2. in the case of a licence held by a body corporate, the body corporate is not a related entity (within the meaning of the Corporations Act) of another body corporate which holds a licence and supplies in the prescribed period:
  - (a) in the case of spirits, 8,750 litres or more;
  - (b) in the case of wine, 28,500 litres or more;
  - (c) in the case of cider, 100,000 litres or more;
  - (d) in the case of beer, 100,000 litres or more.

For the purposes of this Order, *prescribed period* means the period prescribed under section 66AD(1) of the **Liquor Control Reform Act 1998** and set out in regulation 6(a) of the Liquor Control Reform (Wholesale Liquor Supply Information) Regulations 2015, being a financial year.
