NOTICE OF RATE AND THE MINIMUM AMOUNT OF RATE TO BE PAID IN RESPECT OF LAND

I, Lisa Neville, Minister for Environment, Climate Change and Water, being the Minister responsible for administering Part 4 of the **Water Industry Act 1994** (the Act), give notice:

- (i) under section 139(1F) of the Act, for the 2015–16 financial year, of a rate established pursuant to sections 139(1B) and (1C) of the Act in relation to land within the area specified in the Schedule to this Notice. In relation to that land the rate is **0.435** cents per dollar value of the net annual value as at 30 June 1990 levels as determined under the **Valuation of Land Act 1960**; and
- (ii) under section 139(4AE) of the Act, of the minimum amount of rate to be paid in respect of any land within the area specified in the Schedule for the 2015–16 financial year. The minimum amount is **\$72.56**.
