ELIZABETH THE SECOND, by the Grace of God Queen of  
Australia and Her other Realms and Territories, Head of the  
Commonwealth: To the Honourable Linda Marion Dessau AM  
Greeting:

We hereby appoint you Linda Marion Dessau, under section 6(2) of the **Constitution Act 1975** of the State of Victoria to be, during Our Pleasure, Our Governor of Our State of Victoria, in the Commonwealth of Australia.

AND We hereby authorise, empower and command you to perform the powers and functions of the Office of Governor in accordance with the **Constitution Act 1975** of the State of Victoria, the **Australia Acts 1986** of the Commonwealth of Australia and of the United Kingdom, and all other applicable laws.

AND this Commission shall supersede Our Commission dated 1 March 2011 appointing the Honourable Alex Chernov AC QC, to be Governor of Our State of Victoria on 1 July 2015 or, if you have not taken the prescribed Oaths or Affirmations before that date, as soon as you have taken those Oaths or Affirmations.

AND We hereby command all Our subjects in Our State of Victoria and all other persons who may lawfully be required to do so to give due respect and obedience to the Governor accordingly.
