Livestock Disease Control Act 1994

NOTICE OF THE FIXING OF FEES

I, Jaala Pulford, Minister for Agriculture, under sections 48(2) and 104(1) of the Livestock Disease Control Act 1994 (the Act), hereby –

- (a) **revoke** the notice fixing fees for things done under the Act and for the registration or renewal of registration as a beekeeper made on 31 May 2010 and published in Government Gazette G23 on 10 June 2010 (at pages 1172–1174) and amended by a notice made on 23 June 2012 and published in Government Gazette G26 on 28 June 2012 (at page 1379); and
