CONDITIONS UNDER SECTION 220D

I, Richard Bolt, Secretary to the Department of Economic Development, Jobs, Transport and Resources, under section 220D(1) of the **Transport (Compliance and Miscellaneous) Act 1983**, hereby determine the following conditions (the 2015 Amending Conditions No. 1) which amend the conditions under section 220D of the **Transport (Compliance and Miscellaneous) Act 1983** contained in the Victorian Fares and Ticketing Manual (effective 1 January 2015) published in the Victoria Government Gazette No. S 455 dated Monday 22 December 2014.

The 2015 Amending Conditions No. 1 take effect from and including the day they are published in the Government Gazette.

2015 AMENDING CONDITIONS NO. 1

The conditions under section 220D of the **Transport (Compliance and Miscellaneous) Act 1983** contained in the Victorian Fares and Ticketing Manual (effective 1 January 2015) published in the Victoria Government Gazette No. S 455 dated Monday 22 December 2014 (the Manual) are amended as follows.

The amendments made by these amending conditions apply in respect of entitlements to use a public transport service that are subject to the conditions contained in the Manual and that are able to be exercised on or after the commencement of these amending conditions, including entitlements that existed, but had not been exercised, before these amending conditions were published in the Government Gazette.

In Chapter 2 of the Manual, for the first paragraph under the heading '**V/LINE PICK UP AND SET DOWN RESTRICTIONS**' **substitute** –

'A customer may only board a V/Line train at a metropolitan railway station if the V/Line train service ends at a railway station that is not a metropolitan railway station.

A customer may only alight from a V/Line train at a metropolitan railway station if the V/Line train service ends at a railway station that is a metropolitan railway station or with the permission of an authorised person.

If a customer boards, or alights from, a V/Line train at a metropolitan railway station in contravention of either of the two immediately preceding paragraphs, any ticket held by the customer is not, or ceases to be, valid for the customer's journey that consists of, or includes, the customer's travel in that V/Line train or for any entry to a designated area associated with that journey.

In the three immediately preceding paragraphs, '**metropolitan railway station**' means a railway station shown on the Melbourne Train Network Map in Chapter 9 (other than Ardeer, Deer Park, Rockbank and Melton railway stations).'

In Chapter 3 of the Manual, in the paragraphs and table under the heading '**FREE TRAVEL PASSES**', for '(03) 9619 1159' (wherever occurring) **substitute** '(03) 9027 4930'.

In Chapter 3 of the Manual, in the table under the heading '**FREE TRAVEL PASSES**', in the column headed 'Free travel categories (CODE)', for 'EDI/TPI War Veterans' Travel Pass (TV)' **substitute** 'EDA/TPI Ex-service Personnel Pass (TV)'

In Chapter 14 of the Manual, in the sixth paragraph under the heading '**ASSISTANCE ANIMALS**' for '(03) 9619 1159' **substitute** '(03) 9027 4930'.

In Chapter 18 of the Manual, under the heading '**CONTACT INFORMATION**', under the heading '**PTV Hubs**', in the line beginning '750 Collins Street', for '(03) 9619 1159' **substitute** '(03) 9027 4930'.
