### AUTHORISATION AND PUBLICATION PURSUANT TO SECTION 14

#### Instrument Amending The Institute of Chartered Accountants in Australia Professional Standards Scheme (Victoria)

### PREAMBLE

- A. Chartered Accountants Australia and New Zealand (formerly known as The Institute of Chartered Accountants in Australia ('the Institute')) is a national occupational association.
- B. The Institute of Chartered Accountants in Australia Professional Standards Scheme (Victoria) (the Scheme) commenced on 8 October 2014.
- C. The name of the Institute was changed to Chartered Accountants Australia and New Zealand on 26 November 2014 when amendments to the Supplemental Royal Charter and By laws of the Institute were approved by the Governor-General.
- D. This instrument of amendment is prepared by the Institute pursuant to section 18 of the **Professional Standards Act 2003** (Vic.) for the purposes of amending the Scheme.

### AMENDMENTS TO THE SCHEME

1. The Scheme is hereby amended by:
  - (a) replacing all instances of 'the Institute of Chartered Accountants in Australia' with 'Chartered Accountants Australia and New Zealand'; and
  - (b) replacing all instances of 'the Institute' with 'CA ANZ'.

### COMMENCEMENT

2. The amendments shall take effect in Victoria on the date which is 2 months after the date of publication of this instrument in the Government Gazette of Victoria.
