ROAD DECLARATIONS AND DISCONTINUANCE

ROAD DECLARATIONS

VicRoads, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice revokes and declares the roads described in Schedule A and on the plans attached. VicRoads also authorises the access points described in Schedule C and on the plans attached.

ROAD DISCONTINUANCE

VicRoads, pursuant to section 12 of the **Road Management Act 2004**, upon publication of this notice discontinues the part of the road described in Schedule B and on the plan attached.

The effects of these Road Declarations and Road Discontinuances on road names are described in Table 1.

SCHEDULE A

FREEWAY

- a) Those parts of Princes Freeway identified by hatching on the plans numbered GP22819, GP22821, GP22822, GP22823, GP22824 and GP22826 are declared or revoked as described in the legend in the said plans.

ARTERIAL ROAD

- b) Those parts of Corio–Waurm Ponds Road identified by hatching on the plans numbered GP22819A, GP22821A, and GP22822A are declared or renamed as described in the legend in the said plans.
- c) Those parts of Princes Highway identified by hatching on the plan numbered GP22822A are revoked as described in the legend in the said plan.
- d) Those parts of Anglesea Road identified by hatching on the plans numbered GP22824A and GP22827 are revoked as described in the legend in the said plans.

MUNICIPAL ROAD

- e) That part of Pigdon Road identified by hatching on the plan numbered GP22820 is declared as described in the legend in the said plan.
- f) Those parts of Ghazeeopore Road identified by hatching on the plan numbered GP22822B are declared as described in the legend in the said plan.
- g) That part of Eden Court identified by hatching on the plan numbered GP22822B is declared as described in the legend in the said plan.
- h) Those parts of Paget Road identified by hatching on the plans numbered GP22824B and GP22827A are declared as described in the legend in the said plans.

SCHEDULE B

FREEWAY

- a) That part of Princes Freeway identified by hatching on the plan numbered GP22819 is discontinued as described in the legend in the said plan.
