## Road Safety Act 1986

### DECLARATION UNDER SECTION 99B(4) IN RELATION TO NON-ROAD ACTIVITIES IN ESSENDON AND STRATHMORE FOR THE MOONMAN TV SHOW FILM SHOOT ON 15 AND 16 SEPTEMBER 2015

**1 Purpose**

The purpose of this Declaration is to exempt participants in the Moonman TV Show Film Shoot from specified provisions of the **Road Safety Act 1986** and regulations under that Act with respect to the Event, which is a non-road activity to be conducted on the highway(s) listed in Table 2 between 15 September 2015 and 16 September 2015.

**2 Authorising provision**

This notice is made under section 99B(4) of the Act. Section 99B(4) provides that the Minister may, on the application of a person proposing to conduct a non-road activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the Act and of the regulations made under the Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

**3 Commencement**

This notice takes effect at 4.00 pm on 15 September 2015.

**4 Expiry**

This notice expires at 1.00 am on 16 September 2015.

**5 Definitions**

In this notice –

- a) ‘Event’ means the Moonman TV Show Film Shoot, to be held on 15 September 2015 to 16 September 2015. The Event is a non-road activity within the meaning of section 99B(8) of the Act.; and
- b) ‘Participant’ means any person who participates in the Event and has been authorised to do so by Renegade Films.

**6 Declaration**

I, George Mavroyeni, as delegate of the Minister for Roads and Road Safety, declare that the provisions of the Act and regulations specified in Table 1 do not apply to Participants on the highways specified in column 1 of Table 2 on the dates and during the periods specified in column 2 of Table 2, provided there is full compliance with any conditions imposed, or directions given, by VicRoads or the municipal council.
