ROAD DECLARATIONS AND DISCONTINUANCES

ROAD DECLARATIONS

VicRoads, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice, declares or revokes the roads described in Schedule A and on the plans attached. VicRoads also authorises the access point described in Schedule B and on the plan attached.

ROAD DISCONTINUANCES

VicRoads, pursuant to section 12 of the **Road Management Act 2004**, upon publication of this notice –

- discontinues the parts of the roads described in Schedule C and on the plans attached, subject to the right, power and interest held by the Authority over the Identified Land shown in Schedule D and on the plans attached, as provided for in section 207C of the **Local Government Act 1989**; and
- approves the sale of the surplus land as provided in section 94 of the **Transport Integration Act 2010** and as delegated by the Minister for Roads and Road Safety under section 31 of the latter said Act.

The effects of these Road Declarations and Road Discontinuances on road names are described in Table 1.

SCHEDULE A

FREEWAY

- That part of Western Ring Road identified by hatching on the plan numbered GP21042 is declared as described in the legend in the said plan.

ARTERIAL ROAD

- Those parts of Cooper Street identified by hatching on the plans numbered GP22507 and GP22508 are revoked as described in the legend in the said plans.
- That part of Whittlesea–Yea Road identified by hatching on the plan numbered GP23161 is declared as described in the legend in the said plan.
- That part of Yan Yean Road identified by hatching on the plan numbered GP23140 is declared as described in the legend in the said plan.

MUNICIPAL ROAD

- That part of Robinsons Road identified by hatching on the plan numbered GP21785D is declared as described in the legend in the said plan.
