Marine Safety Act 2010 Section 184

WATERWAY RULE

I, Brian Adrian Mnew, Deputy Director Vessel Safety and NSCVS (as delegate of the Director, Transport Safety) make the following waterway rule under section 184 of the **Marine Safety Act 2010**.

Schedule 110

Waters: Hazelwood Cooling Pond

Waterway Manager - Latrobe City Council

After clause 110.2 insert:

Vessel Operating and Zoning Rules for water levels as being 200 mm or more below the Hazelwood Cooling Pond spillway.

110.3 Five (5) knot speed restriction zones for the purposes of Clause 7.

All the waters of Hazelwood Cooling Pond excluding those areas designated as prohibited to vessels are subject to a speed restriction of five (5) knots.

Marine Safety Act 2010 Section 211(1)(b)

NOTICE CONTROLLING NAVIGATION IN THE VICINITY OF WORKS

I, Adrian Mnew, Deputy Director Vessel Safety and NSCVS (as delegate of the Director, Transport Safety) make the following notice under section 211(1)(b)(i) of the **Marine Safety Act 2010**.

For the purposes of the works activity proposed by Elstone Diving Services Pty Ltd. for the installation of an outfall pipe at Point Roadknight near Anglesea, persons and the navigation and other movement of vessels is prohibited within the area bounded by the points detailed in Table 1 excluding persons and vessels involved in the works.

Point A (WGS 84)	38° 24.416498′ S	144° 11.949910′ E
Point B (WGS 84)	38° 24.369542′ S	144° 12.074259′ E
Point C (WGS 84)	38° 25.103190′ S	144° 12.420055′ E
Point D (WGS 84)	38° 25.140770′ S	144° 12.291267′ E

The works area exclusion zone extends approximately 1400 metres from shore in a south-easterly direction. The exclusion zone is 200 metres in width.

The exclusion zone is operational from 0730 am on Sunday 8 November 2015 to 1600 pm on Wednesday 11 November 2015.
