

PROPOSED COMMUNITY AMENITY LOCAL LAW NO. 2 2015  
– OPEN FOR PUBLIC CONSULTATION

At its Ordinary Meeting held on 7 December 2015 Latrobe City Council resolved to make the Community Amenity Local Law No. 2 2015 in accordance with sections 111 and 119 of the **Local Government Act 1989**.

The purposes of this Local Law are to:

- a) provide for the peace, order and good government of the municipality;
- b) prohibit, regulate and control activities, events, practices or behaviour on Council Land, public places and private property;
- c) protect Council's assets and regulate their use;
- d) enhance the quality of life for residents and visitors to the municipality;
- e) provide for matters which require a Local Law under the **Local Government Act 1989** and any other Acts; and
- f) provide for the administration of Council powers and functions.

The proposed Local Law may be inspected during office hours at: Latrobe City Council Headquarters, 141 Commercial Road, Morwell, Victoria; Traralgon Service Centre, 34–38 Kay Street, Traralgon, Victoria; Moe Service Centre, 44 Albert Street, Moe, Victoria; and Churchill Hub, 9–11 Philip Parade, Churchill, Victoria; or viewed at Council’s website, [www.latrobe.vic.gov.au](http://www.latrobe.vic.gov.au). Copies of this proposed Community Amenity Local Law No. 2 may be obtained, free of charge, from any of the above service centres.

Any person affected by the proposed Local Law may make a written submission.



 Amendment C206

The Cardinia Shire Council has prepared Amendment C206 to the Cardinia Planning Scheme. The land affected by the Amendment is:

- Proposed Lot 1 PS 702042V currently known as:
  - Lot 1 Plan of Subdivision PS 439766Q
  - Lot 1 Plan of Subdivision PS 501792U
  - Lot 2 Plan of Subdivision PS 501792U.



The Amendment proposes to:

- rezone land for the Rural Conservation Zone – Schedule 2 to the Public Park and Recreation Zone;
- delete the Environmental Significance Overlay – Schedule 1;
- amend the Schedule to Clause 52.03 to establish a site-specific control to regulate subdivision and re-subdivision of the subject land;
- amend the Schedule to Clause 81.01 to establish an incorporated document to regulate subdivision and re-subdivision of the subject land; and
- consider concurrently planning application P1501 development of the land for the purpose of a minor sports and recreation facility (netball courts and pavilion), associated car-parking and alteration to access to a Road Zone Category 1.

I, Darren Schultz, Building and Contracts Officer of Loddon Shire Council, waterway manager for the Loddon River (at Bridgewater between Flour Mill Weir and Sweeney's Lane), declare under section 203(3) of the **Marine Safety Act 2010** that the 2016 Australian Masters Tournament Water Ski Championships on 23 and 24 January 2016 is exempt from:

1. The requirements of Clause 62.2 (in relation to the 5 knot speed restricted area between the exclusive use and special purpose areas detailed in clauses 62.6 and 62.7).
2. The requirements of Clause 62.7 (in relation to the operating rules for exclusive use and special purpose area) of Schedule 62 of the Notice under section 15(2) of the **Marine Act 1988**.
3. The requirements of Regulations 103 and 104(2) of the Marine Safety Regulations 2012, in respect to persons being towed by a vessel to wear a PFD and masters of recreational vessels must not tow a person unless the person is wearing a PFD. This exemption applies to trick skiers only.

This declaration applies to registered participants of the 2016 Australian Masters Tournament Water Ski Championships from 7.30 am to 7.00 pm on 23 and 24 January 2016 on the waters of the Loddon River in the gazette Exclusive Use and Special Purpose Area detailed in Clause 62.7 of Schedule 62 (waterway rules for the Loddon River at Bridgewater), provided that all vessel occupants are wearing a PFD and that the stated safety controls and undertakings detailed in the Event Application and associated documentation are adhered to.
